RE: HF97/SF224 Legislation to reinstate all drivers in Minnesota to apply for driver's licenses regardless of immigration status

Honorable Legislators,

Thank you for your leadership in bringing forth this important legislation. As Ramsey County Attorney, I am concerned about the prevalence of unlicensed drivers in Minnesota. I understand that in 2002, there was a change in the rules governing driver's licenses which resulted in restricting driving privileges to only U.S. citizens and legal residents. I am aware that there is bipartisan legislation currently introduced that would reinstate the ability for all drivers in Minnesota to apply for a driver's license regardless of immigration status, and that these licenses will include a "status check" on them.

Statewide, nearly 20 percent of drivers do not carry insurance, according to the Insurance Federation of Minnesota. This percentage skyrockets for undocumented immigrants since one must have a valid driver's license in order to secure insurance. As most driving accidents are caused by unlicensed motorists, we clearly have a problem in our community that requires your attention as lawmakers.

Allowing all drivers to apply for a driver's license will ensure that everyone driving on our roads is required to pass an exam demonstrating knowledge of our traffic laws and regulations. It will also increase the likelihood of drivers carrying auto insurance.

A number of states have prioritized public safety by passing laws allowing their residents to apply for a driver's license regardless of their status. I understand that, according to the proposed legislation, the requirements to obtain a driver's license without a social security number will be very stringent. I support this measure because I believe it will result in more licensed, insured drivers on our roads and thereby enhance public safety.

I fully endorse HF97/SF224 so that we can make our state a better and safer Minnesota, and I hope the legislature will as well. Please feel free to contact me if I can be of further assistance.


Dear Senator Champion and Representative Hamilton:

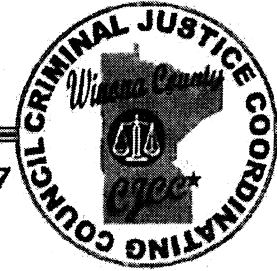

The Winona County Criminal Justice Coordinating Council (CJCC) supports House File 97 and Senate File 224 and strongly encourages the Minnesota State Legislature to approve this legislation. These bills enhance public safety by allowing all Minnesota residents, regardless of their immigration status, to obtain a Minnesota driver's license.

Since its formation in 2007, the CJCC has advocated for changes to the existing Minnesota driver's license law that echoes the sentiment of House File 97 and Senate File 224. The work that the CJCC has done has gained great support not only from our committee members, but also from our community as a whole. The following statements from our CJCC members represent the CJCC's position on this issue:

"People who are living and working in our community need to have both a valid driver's license and motor vehicle insurance; they must also be required to abide by all the rules of the road that the State of Minnesota has. A law providing for such legal driver's licenses will reduce accidents and provide liability, both of which will be significant contributions to the State. There is no doubt that if the State is not going to deport individuals, that providing them with training such as road tests is absolutely necessary to help protect all of our residents." – **Ron Ganrude Winona County Sheriff**

"It is a public safety as well as a fairness issue that immigrants who reside, work, and raise their children in our community are denied the opportunity to become licensed drivers simply because of their immigration status. It is a small step in immigration reform, but a huge leap in public safety policy and reducing the costs to society to allow such immigrants to apply for a driver's license. Statistics show that



Honorable Legislators,

Thank you for your leadership in bringing forth HF97/SF224. I am writing to express my support and full endorsement for HF97/SF224, which will allow all Minnesota residents to obtain a Minnesota driver's license, regardless of their immigration status.

My endorsement supports a plan that requires drivers, without proof of a previous driving license in another country, to complete the same driver education course(s), prior to taking the "behind the wheel test", any other new driver in the state is subject to. By doing so, we can ensure that everyone driving on our roadways is knowledgeable of our traffic regulations, enhancing the safety of our roads.

As law enforcement officers, we often see uninsured and unlicensed drivers at accident scenes. The Insurance Federation of Minnesota estimates that approximately 20% of drivers do not carry insurance. The estimate climbs to a much higher level for undocumented immigrants who cannot obtain auto insurance without a valid driver's license. With many accidents involving an unlicensed driver, the importance of this bill is clear.

In addition to the benefit of allowing undocumented immigrants to obtain auto insurance by having a license, it is important for officers to be able to properly identify the drivers of the vehicles they stop. Without a license, this becomes a very time consuming incident for our officers and takes away their time from other important tasks.

My hope is that HF97/SF224 will make our state roadways safe for all drivers, decrease the number of uninsured drivers, and ensure officer's time is well utilized. Please feel free to contact me if I can be of any further assistance.

I understand that in 2002, there was a change in the rules governing driver's licenses which resulted in restricting driving privileges to only U.S. citizens and legal residents. I am aware that there is bipartisan legislation currently introduced that would reinstate the ability for all drivers in Minnesota to apply for a driver's license, regardless of immigration status.

Allowing all residents to apply for a driver's license will help ensure that more people driving on our roads pass an exam, demonstrating knowledge of our traffic laws and regulations and proficiency with behind the wheel testing. It can also improve the likelihood of more drivers carrying auto insurance through ease of obtaining it with a state issued license.

As law enforcement, it is important that residents have a state issued identification which includes their address. 

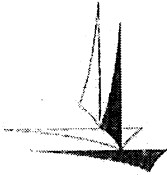
