Primary Duties and Responsibilities:

This position is responsible for implementation of a comprehensive program of naturalization workshops, screenings, and application assistance, in collaboration with the Mexican Consulate. Through this program, ILCM will address the need for naturalization assistance in communities in Minnesota, North Dakota, South Dakota, and Wisconsin. This position is part-time, temporary at .50 FTE (full-time equivalent) through December 31, 2017.

Responsibilities will include:

- Develop and provide naturalization workshops in Minnesota, North Dakota, South Dakota, and Wisconsin.
- Provide naturalization legal screenings for workshop participants, to assess eligibility for naturalization.
- Provide application assistance services to individuals in completing and filing naturalization applications, including review of documents and assistance with completing and submitting the naturalization application.
- Provide full immigration representation to individuals and families, specifically in naturalization applications before USCIS.
- Engage in outreach efforts to immigrant and refugee communities regarding our legal services.
- Maintain client data in compliance with organization protocols and in compliance with grants and contracts.
